You must also ensure that your Annual Returns are completed and submitted on time.
- Entry of a charity's name on the Register does not give that charity any legal rights to that name. We can direct a charity to change its name if it is the same as or too similar to that of another charity or if the name is misleading or offensive. We will not be responsible for any costs involved, incurred directly or indirectly by a charity where we have directed a change in the charity's name.
